Help Shape the Future of Resilience

Leaders from industry, government and academia are invited to participate in the 2016 Critical Infrastructure Symposium (CIS) by submitting an abstract of a presentation and/or paper.

Now in its seventh year, CIS continues to showcase innovative research and best practices, and explore new challenges for building a more resilient and sustainable infrastructure. The Symposium is a collaborative learning community of students and professionals engaged in developing the next generation of critical infrastructure security and resilience leaders, technologies, strategies and solutions.

The 2016 CIS is built around the theme, "Resilience: An Infrastructure, Social and Economic Imperative." The technical program will include 12 sessions, each with up to four presenters from inter-related disciplines across the resilience community. Papers and presentations are solicited for these topics:

- Social and Economic Resilience
- Design Philosophies for 22nd Century Design
- Critical Infrastructure Security and Resilience Education
- Impacts of 3D Printing on Infrastructure
- Evolution of the 21st Century Terrorist Threat
- Concurrent Hazards Analysis
- Electrical Power Resilience
- Transportation Resilience

Authors also are encouraged to submit papers and presentations on their unique infrastructure research and projects.

CIS Publications

To improve the accessibility, usefulness, speed and professional quality of our publications, we will begin publishing CIS submissions in three formats:

- Presentation + full paper (5,000+ words). These papers will be peer-reviewed
 after the CIS and, if of sufficient quality, be published as CIS Proceedings and
 archived on the SAME website.
- **Presentation** + 1,500-word supporting essay. Based on recommendations from the moderators and the CIS committee, these short-form articles will be submitted to The CIP Report (published by George Mason University) for publication and presentations will be archived on the SAME website.
- Presentation with annotated speaker notes. Detailed notes explaining the slides will be placed in the notes section of the slide to allow the slides to be cited, used and explained by others. These annotated slides will be archived on the SAME website.

Submission Instructions

All individuals must submit an abstract of his/her presentation. All presenters will be selected based on the abstract. A final paper may be submitted to be considered for publication in one of the formats listed in the "CIS Publications" section. Each abstract must contain the following information:

- Paper title;
- Author(s) name and affiliation;
- Faculty advisor and affiliation (for students);
- Keyword description of subject and hazard;
- Type of submission—full paper, supporting essay, or annotated speaker notes;
- 400-word abstract; and
- 100-word biography of the primary author.

Abstracts that contain the following information will have a higher chance of being accepted: contain a clear and supported thesis; provide accurate information and show a succinct description of the research objective and how it relates to the thesis; and feature a relevant subject that provokes dialogue and appeals to symposium attendees.

The file must be set up as "AUTHOR LAST NAME—PAPER TITLE.pdf" and e-mailed to Jacqueline Barrett at *jbarrett@same.org* by **DECEMBER 18, 2015**. All abstracts will be reviewed and notifications sent to submitters whether their paper or presentation abstracts are accepted. Presentations will be in PowerPoint.

Abstract Evaluations

Abstracts are evaluated using a peer review process. Each abstract is evaluated by a subject matter expert against the following criteria: quality of abstract, accuracy, overall quality of writing, and relevance of the subject.

The peer review process takes three weeks to complete. Abstracts submitted prior to December 1, 2015 will be considered for early acceptance. Notifications of acceptance for the 2016 CIS will be sent out by JANUARY 15, 2016. If you would like to participate in the review process, contact Jacqueline Barrett at *jbarrett@same.org*.
